

MOVED by Lori Arndt and SECOND by Barb Pigott that the congregation receive an offer to purchase Northminster United Church building located at 3311 Centre Street NW, Calgary, AB.

Conditions and details of sale shared with the congregation:

- Northminster received an offer to purchase from Fairview Baptist Church on Nov 03, 2022
- offer met full asking price of \$4,250,000.00
- initial deposit of \$100, 000.00 received Nov 7, 2022
 further deposit of \$350,000.00 to be paid by April 6, 2023. Money is held in trust until possession date on May 31, 2023
 building inspection to be completed booked for Dec 6, 2022
- Fairview's church property and building must be listed on MLS on or before Dec 9, 2022 and have firm sale by March 31, 2023
 Fairview's congregation has approved the purchase of Northminster building and property Northminister congregation must approve the sale of building and property by Dec 9, 2022

All conditions and details of sale are subject to approval of Chinook Winds Region

Questions for clarification around details, conditions, process:

(Noted that we cannot make amendments to the conditions of sale as we have already directed the trustees to move forward with the conditions as presented)

Questions for clarification included:

- do we need to make any renovations or improvements to the building No, pending results of building inspection
- implications of March 31, 2023 condition that Fairview must sell their property no major concerns identified by Realtor at Task Force meeting.
- involvement of Chinook Winds Region no church property can be sold without the Region's approval. Sue Broderick has been involved with the Task Force all along and sees no reasons for concern – next meeting of Property Working Group is Dec 8, 2022
- has the Real Property Report been completed yes, this has been completed and registered with the City of Calgary. Is awaiting approval. Does not need to be approved by the buyer.
 Noted that commercial sales differ from private property sales.

Sue Broderick recommended that, for clarification, the mover and second agree to change the wording of the motion to read "accept" (rather than "receive") an offer to purchase . . . AGREED

Voting process explained by Barb McPherson

- ballots distributed to people in-person and counted
- people on Zoom are to vote in the chat. They are to type their name and then state (type) whether they vote "yes" or "no". Mary Anne will note these votes.

Results:

100% of those present and attending by Zoom voted "yes"
 Motion CARRIED
 All ballots shredded according to process

Next steps: Sue Broderick

- letter to be sent from Northminster trustees requesting that Chinook Winds Region Property Working Group approve the offer to purchase the Northminster building and property. Minutes of congregation meeting to accompany the letter
- Chinook Winds Executive Minister, Treena Duncan, will review and send decision back to Northminster
- following approval, all conditions for sale must be met
- once sale is complete, all money is held in trust and cannot be spent until Northminster has an
 approved plan in place. Some financial support is available, from the capital of the sale, to hire
 consultant(s) to assist in the development of our plan with approval from the Region
- as interest accumulates on the principle funds received from the sale, it can be used to support
 Northminster ministry going forward
- in the new year Northminster must decide "what does the future look like for Northminster?"

Lawyer recommendation:

- Ryan McCall from James and McCall Barristers has been appointed
- all documentation has been sent. Awaiting cost agreement which will be sent to the Board for approval

Noted that:

- in 1953 Northminster land was \$10, 000.00 and building \$359,000.00. The elevator was an additional cost
- Current rental agreements have been extended to May 31, 2023
- the Task Force will continue to work with Realtor, Joe Belland, until completion of the sale. At that point their work will be completed. They may wish to continue with future steps around ministry and property planning alongside new volunteers who will be needed to take us forward.

Barb McPherson thanked all who volunteered and who attended this meeting.

MOVED by Jean Love that the congregation meeting be adjourned at 1250.



A MESSAGE FROM REV. NANCY NOURSE

This year Northminster did something together not many churches have done, although it's quite biblical in nature. In 2021 after years of guidance from the dedicated leadership of the Task Force, we stepped away from our sacred space at 3311 Centre Street North where we had shared in almost 70 years of history together. It was the place for Sunday worship and community outreach. It was the place where weddings were celebrated, and babies were baptized. The building was a place of milestones and support in difficult times. Memories of times shared will always be deeply treasured.



And yet we realized that our future was calling us away from that space. While 3311 Centre Street North may have been the only place we'd known as "church" for generations, together we stepped away from that location and moved toward a future yet unknown. Like the Israelites who had left Egypt with the hope of a Promised Land, we are circling the wilderness for a bit. In the meantime, we have landed at a temporary home called St David's United Church.

I think Covid taught us we could be a church without a building. And since May 1st, we have been a church in a new building. We continue to live out our identity of Welcoming Celebrating Becoming. We continue to work through the Affirming Ministries process, we seek ways to engage the community in our new neighbourhood with livestreaming worship, and events like Trunk or Treat, the Craft Fair, and the Outdoor Nativity. Together we still share in our music ministry on Sunday mornings, provide kidZone to nurture the spiritual development of our children and youth, and we find ways to seek justice in the world with supporting the Mission and Service Fund and partnering with the Kerby Centre for the bread market. Together we still enjoy men's breakfast, Saturday crafting, the book club, seasonal studies, and fundraisers to support the ministries of the church.

We are the church wherever we go. And God is guiding us and nurturing us on this journey. While we are getting closer to determining a final destination, we still strive to support one another and be Northminster along the way. As the hymn says, "And it's from the old I travel to the new, keep me traveling along with you."

I am so grateful for the faith and courage you show. Your prayers matter, your financial gifts make a difference and show that you have hope for the future, and your time and talents continue to weave this beautiful fabric that is Northminster. I also want to thank all the staff for their commitment to seeing Northminster through this time. And for the Board as you have endeavoured to explore what adaptive leadership means...leaders who are thinking missionally and not just reactively. Thank you for the effort you have given to book studies and retreats and prayerfully making decisions that will guide Northminster into the future.

BOARD MINISTRY REPORTS

ADMINISTRATION COMMITTEE DISCUSSION AND ANALYSIS

Overview

The Administration Committee is responsible for the maintenance of the Church building and property and the management of the Church's financial resources. This includes setting budgets, ensuring that members' contributions are deposited and accounted for, rents are negotiated and collected, operating costs are up to date and employees are paid as per the budget. All financial reports are prepared by the Treasurer and all income and donations are reconciled by the Envelope Secretary.

2022 Financial Overview

2022 Income: \$223,126 2022 Expenses: \$269,322 2022 Loss: (\$41,196)

Canada Emergency Business Loan (CEBA)

As a result of the COVID-19 pandemic, Northminster United Church applied for and received a \$40,000 loan from the Government of Canada in 2020. In 2021 we applied for an received an additional \$20,000. This loan is repayable to the Government of Canada and includes a forgivable amount of \$20,000 if \$40,000 of the loan is repaid prior to December 31, 2023. \$40,000 was repaid in 2022 and \$20,000 was included in income in 2022.

Thank you to Ted Carter and Ron Hiebert who act as our Building Coordinators. Thank you to the administration team, Dorothy Gautreau, Kim Haydu for the many hours involved in managing the Church Finances.

Our thanks also go out to our Church employees and to the many volunteers who give their time and talents throughout the year. Please know that your volunteer work throughout the year does make a difference.

BUILDING COORDINATORS REPORT 2022

The Building Coordinators work in conjunction with the Administration Division. We are tasked with a variety of tasks related to maintenance, repairs, and general upkeep of the Church Facility. In some cases, we perform maintenance functions, while in other instances we oversee the work of contractors and other vendors who provide services. We also make recommendations to the Administration Division of repairs and maintenance required.

These are a few of the various projects that the Building Coordinators have taken care of during the past year.

Plumbing

Arrange to have our Boiler Maintenance performed two times per year. One in January and one in June. This is done so we will pass the Alberta Government Boiler Inspection Code required annually. Involved with the Boiler Inspection we are required to have a certified plumber certify annually that the Cross Connection Vales are functioning as per the City of Calgary Bylaw.

This year we had to replace a Circuit Board and two blower motors on the two motors that heat the sanctuary.

Elevator

Arrange to have the Elevator serviced two times per year. We need to have the Elevator Inspected annually to obtain the permit so it can be operated. This is done by the Alberta Elevating Devices and Amusement Rides Safety Association.

Fire Extinguishers and Emergency Lighting Devices.

Arrange to have the Fire Extinguishers tested annually to meet the Code requirements. There are ten (10) Fire Extinguishers in the Church. As well we are required to keep a log of the testing of the ten Emergency Lighting Devices monthly to meet the City of Calgary Fire Code.

Rentals

Work with rental committee or designate to ensure and make recommendations on maintenance and cleaning responsibilities required due to the space being rented or used by outreach groups.

Sidewalk, Parking Lot Snow Removal and Lawn Care

Work with Administration Division recommending Contractors to perform this work and handle any complaints received and work with contractors to have the issue corrected. The Parking Lot and Sidewalk contracts run from October 15 to April 15 of each year. The Lawn Maintenance contact runs from May to September.

The Building coordinators perform light bulb changes as required, small maintenance jobs, as well as tree trimming and changing the sign. We work in conjunction with our Janitorial Contractor Ramiro Mara to ensure he has all the supplies required to do the janitorial work. We perform work to ensure our building is safe and meets all the Civic and Provincial Code requirements.

What a wonder-filled sign of hope spring is.It's how I feel about our KidZone kids; full of energy, wonder, new ideas, and hope.

Julie and I (Tracey) teach the Spark class (age three to Grade three). Until May 2022 our Glow class (Grades four to six) was taught by Michelle Peterson and Nicole Vandervoort. We thank them for their willingness to serve but unfortunately both of these women had to step down due to work and family conflicts so we made the decision in September to make the Shine class (Grades six and up) include Grades four to six as well. This arrangement is working but it does mean we have a very large age range in this division. If you would like to make a difference in the lives of young children, please talk to Tracey Abbott or Rev. Nancy as we would love to have a dedicated Glow class again. Please prayerfully consider whether you might be able to help. The Shine class and Youth group was taught by Mary Anne Wickerson until May 2022 when Mary Anne stepped down from this role to devote more time to her many other roles. We thank her for her love, creativity and dedication to our youth for the past three years. Over the summer we accepted applications for this position and in September we hired Emily Osgood. Emily is fitting in nicely and has some exciting plans for our youth. Watch the bulletin and newsletter for updates!

We are continuing to use Sparkhouse digital for our curriculum. Besides being easy to access because it's online, it offers easy to follow lessons and activities for our coaches. Sparkhouse also has extra resources like a Family Page we print out and send home which includes a prayer, conversation starters, and activity ideas for families to do together.

We generally follow the lectionary. Bible stories we've covered since last January include: Jesus' Baptism (Luke 3:15-17,21-22), Calling the Disciples (Luke 5:1-11,8:1-3), Wedding at Cana (John 2:1-11), Jeremiah (1:4-10), The Lost Sheep and the Lost Coin (Luke 15:1-10), the Parable of the Rich Man (Luke 16:19-31), Seeds of Faith (Luke 17:5-10), the Pharisee and the Tax Collector (Luke 18:9-14), and Zaccheus (Luke 19:1-10). Most Sundays our Spark class averages between 4-6 kids however it's not uncommon for us to have 7-8 children join us.

Some highlights of the year were: return to in-person KidZone class on March 6/22, Palm Sunday presentation "Footsteps" by KidZone kids, Welcome Back Sunday on September 11/22 with Backpack Blessing, and KidZone Christmas Play, "Count on It" by Bari Castle, Linnea Good and adapted for us by Rev. Nancy.

Julie and I sincerely enjoy working with the KidZone Spark class. We invite you to come downstairs to check out our classroom sometime and we hope you find wonder-filled signs of spring in the weeks to come.

LIVESTREAM

MISSION & OUTREACH

In 2022, the Mission and Outreach (Service) division partnered with the Kerby Centre and launched a new program out of Northminster, the monthly Bread Market. Kerby receives unsold bread and pastries from Cobbs and Starbucks and then provides it to centres around the city for free distribution to anyone, not only seniors, who can use a loaf of bread, package of buns or some treats. We put a notice on our exterior sign and have advertised it in community newsletters and word is getting out. Most months the market attracts about 25 persons from the surrounding community. Any remaining items are delivered to some of Northminster's own seniors.



In June, shortly after our congregation moved to St. David's, our division sought donations of clothing and tents for the Indigenous Friendship Centre. There was a wonderful response from both congregations.

In October, we undertook a "Coins for Pakistan" campaign to raise money to help people in Pakistan where millions of people lost their homes and land due to heavy monsoon rains. The two congregations contributed a total of \$679 to the Humanitarian Coalition that raises money on behalf of a dozen non-governmental organizations.

Although in previous years we have supported the young mothers' program at the Alex Centre in May, Rev. Nancy suggested that for Christmas 2022 we invite congregants to contribute to a "Baby Shower for Mary." The division also donated money for some breast pumps. The Alex staff were most appreciative and said they were overwhelmed by the generosity of Northminster and St. David's.

PASTORAL CARE

The year of 2022 has been one of transition, where communication was especially important. When the church began services in person the worship packages Rev. Nancy provided to seniors without email were discontinued, but Newsletters and other important church information continued to be mailed.

When it was decided Northminster would partner and move to St David's United church extra phone calls were made to senior members to provide information and offer rides, so they could attend the last service at Northminster April 24 and the Commemorative service May 15. We continued to offer rides to St David's services for those who requested it.

In May our Pastoral Care Committee met with St David's Pastoral Care chair and some of their members. It was an introduction with discussions about what we each did. Our Pastoral Care Committees presently remain separate.

Visitations were made when possible and with the help of many volunteers meals were delivered and rides for appointments provided when needed. We continued to put special Birthdays and In Memoriams in the church weekly emails. Margaret Kobol celebrated her 100th birthday in August and we had a lovely visit with her when we delivered her card from Northminster. We sent many cards for different occasions.

This fall extra calls were made to assist with the pictorial directory and check addresses. At Christmas the UCW provided 14 beautiful Christmas baskets for seniors. The Pastoral Care Committee also provided 9 plates of Christmas cookies for the other seniors. All were delivered personally, and gratefully received. Extra Christmas cards were not sent since the Northminster Board sent out cards.

Commune-I-Care

This ministry provides the opportunity to stay connected to the church family with phone calls three times a year February, May, and October. It allows us to reach out with friendly conversation, listening to concerns or needs and update changes in addresses and phone numbers. Pastoral Care referrals were sent to Rev. Nancy, others to the office or appropriate committee so they could be addressed. We have 10 dedicated callers who contacted 78 families/ individuals with each callout. Thank you for your time and friendship.

Home Communion has not yet been restarted.

Prayers of support and healing are offered by contacting the church office. This year there were 27 prayer requests passed on to the 18 members of the prayer chain, who faithfully offered loving prayers.

TRUSTEE REPORT

The Trustees of Northminster UC are responsible for overseeing the operation of the church and hold the property of the congregation, in trust, for the use and benefit of the congregation as part of the United Church of Canada.

Throughout the last year, the Trustees have been engaged in Zoom meetings and other forms of discussion between the Northminster Board, Task Force and Realtor in regards to the sale of Northminster Church. At a November 2, 2022 Special Meeting of the Board including all Trustees it was agreed in principle to accept the sales agreement and to recommend such agreement to the congregation at a Special Congregational Meeting.

At a Special Congregational Meeting held December 4, 2022 the offer of sale was approved with a final possession date of May 31, 2023. The Trustees received a letter of approval for the sale from Chinook Winds Region and documents were signed December 20, 2022.

Insurance coverage is the other major responsibility of the Trustees. We need to maintain coverage and liability even though we are not occupying Northminster building full time and need to consider coverage as we still have rental clients. Jim Dallman, our knowledgeable insurance Trustee, has renegotiated the annual insurance coverage and recommended that we change insurers to Mennonite Mutual with a savings of \$5,500 annually including increased coverage. COMMUNICATION & COMMUNITY ENGAGEMENT

Communications and Community Engagement Report - Submitted by Mary Anne Wickerson
From January to October, we continued with our partnerships with the City of Calgary and the Highland Park
Community Association, focusing on initiatives like the Human Library and the Indigenous Learning Series. After
many months of planning and development the Human Library launched in the fall - its main goal is to connect
community members through the sharing of talents, skills, and experiences. Much of my work in support of this
initiative was in communication - designing templates for Human Book profiles, social media promotions,
designing logos, and other visuals. The Indigenous Learning Series was the main focus of our TRC work in
Partnership with The City of Calgary. Working closely with Jennifer DiMarzo, social worker from the City of Calgary
we planned opportunities for community members to engage in learning opportunities. Jennifer hosted two
sessions of a book club-style discussion group for community members taking the free University of Alberta
Coursera Indigenous Canada Course. We also planned for the launch of the Indigenous Film Series which began in
the winter. Again, along with help in the planning, much of my work was in communication – designing
promotional materials, logos, social media graphics, etc.

Supper for the Soul continued from January to May with presentations about such things as healthy living, a behind the scenes look at curling broadcasting, a chat with an up-cycler and discussion about living with a focus on sustainability and learning about Northminster's involvement in the Highland Park Human Library Project. We connected monthly on Zoom and enjoyed conversation and hearing from our engaging guests.

In the early fall, as we settled in after our move to St. David's, and as we continued to discern our future and where we will end up, the main scope of my work shifted more to communications. My job title became "Communications and Community Engagement" – recognizing this shift.I continue to work closely with Barb Johnson and Rev. Nancy, as well as the SDUC admin so that I know of upcoming events and initiatives to share with the congregation and the greater community. I create graphics to promote upcoming events and to celebrate events that have occurred (sharing photos, etc.), promote upcoming activities, schedule social media posts, #Mondayinspiration posts, and Friday Funnies. As well, I create the weekly announcement video, as well as creating the bumpers for use during worship on the screen for those in the sanctuary as well as those who tune in on our Livestream. Our many fall activities were promoted to the communities around St. David's. It was wonderful to see families and individuals from around the neighbourhood come out to events such as the Pet Blessing, Trunk or Treat, Craft Fair, Merry and Bright Caroling Night, the Outdoor Nativity and more. Many people said that they had heard about us through social media. I have joined several of the surrounding communities' social media groups and they allow promotion of events on certain days of the week, and this has been a successful way to communicate and share our events with our new neighbours.

It has been an exciting year at Northminster, and I feel so fortunate to be a part of this wonderful community.





CHINOOK WINDS REGION



Chinook Winds Region (central and southern Alberta) continues to meet with Pacific Mountain Region (British Columbia - except the most northeastern part of the province) on a regular basis. We also meet in geographical cluster groups (ours is north of the river in Calgary) to discuss issues specific to us and also network ideas. TASK FORCE REPORT

When you look back to when the Task Force was formed in June 2019 we have reviewed a major amount of information and presented a lot of material to the Board and Congregation to discuss and approve.

We have gone from the option of knocking down our current building and rebuilding on the same site with our Church on the main floor and adding condos above. Another option was selling our facility and purchasing some land to build a new church or buy an existing building that meets our needs. Meetings were held with various community agencies on the potential to share ideas and possible partnerships as well.

The Task Force met with the Board through 2022 and gave updates at their monthly meetings to keep them informed where we were in the process and to receive their input and feedback.

During 2022 the Task Force has continued our relationship with Joe Belland of StonePoint Realty to sell our Church. We had verbal offers from the Antiochian Orthodox Church; however they did not in the end put in a final offer to purchase so the decision was made to move on. Joe Belland made the decision to have our church listed on CLS (Commercial Listing) and on Commercial listings in Western Canada.

On November 02, 2022 the Fairview Baptist Church made an offer to purchase our church. November 03, 2022 the Trustees agreed to the offer to purchase from Fairview Baptist Church for the price of \$4,250,000 with a possession date of May 31, 2023 The Trustees then presented the offer to the Board for their approval. The Board called a Congregational Meeting to be held December 04, 2022, to explain the offer and seek approval. The members present approved that we accept the offer. The Trustees then forwarded this offer to Chinook Winds Region for their approval and they approved the sale.

As a result of this purchase to offer the Task Force had a Phase 1 Environmental scan completed on our church. As well we had a Real Property Report completed. We hired the Law firm of McCall and James Barristers to handle the legal side of the sale. All this was done in conjunction with the Board, Trustees and Chinook Winds Region.

The Board made the decision that the Task Force would remain as a committee until the sale is finalized on May 31, 2023. We would like to thank Mark Vandervoort and Lloyd Vincent for their input during this process. This has been a very time consuming commitment and the committee remained committed to complete their mandate.

NORTHMINSTER UNITED CHURCH NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2022

1. Significant Accounting Policies

The Northminster United Church (the "church") is a registered charitable organization under the Income Tax Act (the "Act") and as such is exempt from income taxes and issues income tax receipts to its donors for income tax purposes. To maintain its status as an organization under the act, the church must meet certain requirements within the Act. In the opinion of the church Board these requirements have been met.

The church generally prepares its financial statements in accordance with "Accounting standards for Not-For-Profit Organizations". The church is a small not-for-profit organization as its average annual revenues are less than \$500,000. The Church has no future commitments or other affairs that require further reporting.

Donations

Donations are received from members of the congregation of the church and are used to fund the operations of the church as directed by the church Board. Specified donations are segregated and forwarded to the project or fund so designated. Pledges or commitments may be made to the church at the donor's discretion. Donations to the church are recorded as income when received.

Volunteer Labour

The operations of the church and its activities are dependent upon the volunteer labour provided by its congregation. No provision has been made in the accounts for the volunteer efforts provided by the congregation.

Fixed Assets

Included in the fixed assets of the church is the cost of land, building and related fixtures, video system and the elevator. No provision is made in the accounts for amortization of the assets as is appropriate for a small not-for-profit organization. The church capitalizes any significant cost of tangible capital assets and insignificant amounts are expensed. Current market and insurable values are more than cost.

2. Cash and Cash Equivalent

Cash and Cash Equivalents is comprised of both Cash and Term Deposits. Term deposits are monies invested from bequests received. All Term Deposits are redeemable on demand and bear interest at various rates. Due to the short-term nature and liquidity of the term deposits, they are part of the cash balance as a cash equivalent. 3. Long Term Debt

As a result of the COVID-19 pandemic, in 2020 Northminster United Church applied for and received a \$40,000 loan from the Government of Canada. In 2021 Northminster United church applied for and received an additional \$20,000 loan from the Government of Canada. This loan is repayable to the Government of Canada and includes a forgivable amount of \$20,000. This loan was repaid in 2022 and the forgiven amount of \$20,000 was received as income in 2022.

4. Specified Liabilities
